Why do we need the Protect Life Amendment?

In 2018 the Iowa Supreme Court declared a "right" to abortion under the Iowa Constitution and struck down a law requiring a 72hour waiting period before abortion. This 2018 ruling could be used to perpetuate abortion in Iowa even if federal law or Roe v. Wade is changed. As long as this ruling stands, future courts could use it as precedent to overturn any and every state abortion law, rule lowa taxpayers must pay for abortions, and even legalize abortion up to the day of a baby's birth. The Protect Life Amendment would return abortion policy to the people and the state legislature.

How does a constitutional amendment pass?

The ratification of a constitutional amendment requires completing three steps:

- 1. The Iowa House and Senate pass the amendment. This step was completed in May 2021.
- 2. Following the next general election, the Iowa House and Senate pass the same amendment again. This step needs to be completed in 2023 or 2024.
- 3. The majority of lowa voters then approve the constitutional amendment in an election in 2023 or 2024.
